In exercise of the powers conferred by Section 22-B(1) of the Legal Services Authorities, 1987 and in pursuance of the approval dated 22.02.2025 of Hon'ble Chief Justice, High Court of Delhi & Patron-in-Chief, Delhi State Legal Services Authority (DSLSA), the following existing Permanent LokAdalats shall have jurisdiction over **all public utility services** disputes under Section 22A(b) of the Legal Services Authorities Act, 1987, including those services which have been declared as public utility services by the Central Government and the Government of NCT of Delhi (GNCTD), with effect from the date of the notification:
