ADDENDUM NO.4

THIS ADDENDUM NO.4 ("Addendum") TO INTEGRATED FACILITY SERVICES AGREEMENT dated 28th September 2017 ("Agreement") is made and executed on this 11th day of August 2022.

By and between

GO DIGIT INFOWORKS SERVICES PRIVATE LIMITED, a company incorporated under the Companies Act 2013 having its office at Atlantis, 95, 4th B Cross Road, Koramangala Industrial Layout, 5th Block, Bengaluru – 560095 and registered office at Ananta One ,1 to 6th floor, Opposite Shivaji Nagar bus stand , Babulal Sheikh Path, Narveer Tanaji Wadi, Shivajinagar, Pune, Maharashtra 411005 (hereinafter referred to as "Provider" which term, unless it is repugnant to the context or meaning thereof, shall mean and include its subsidiaries, affiliates, representatives and permitted assign) of the **FIRST PART**;

AND

GO DIGIT GENERAL INSURANCE LIMITED, a company incorporated under the Companies Act 2013 having its corporate office address at Atlantis, 95, 4th B Cross Road, Koramangala Industrial Layout, 5th Block, Bengaluru – 560095 and registered office at Ananta One ,1 to 6th floor, Opposite Shivaji Nagar bus stand , Babulal Sheikh Path, Narveer Tanaji Wadi, Shivajinagar, Pune, Maharashtra 411005 (hereinafter referred to as "Client" which term, unless it is repugnant to the context or meaning thereof, shall mean and include its subsidiaries, affiliates, representatives and permitted assign) of the **SECOND PART**;

Provider and Client are hereinafter referred to individually as a "Party" and collectively as "Parties".

WHEREAS

- A. The Provider and Client entered into the Agreement dated 28th September 2017.
- B. Parties are desirous to replace recital to make correction in Recital – A in which the term is inadvertently mentioned as valid till 31st March 2033, the Parties have executed this Addendum to clarify that the premises situated at Atlantis, Site Number – 95, 4th B Cross Road, 5th Block, Koramangala Industrial Layout, Bengaluru – 560095, is taken upon Lease till 31st March 2032.

PARTIES AGREE AS FOLLOWS:

1. The below mentioned Recital - A of the Agreement are to be replaced with the revised clause mentioned below:

Existing Clause:

The Provider has taken the premises situated at Atlantis, Site Number – 95, 4th B Cross Road, 5th Block, Koramangala Industrial Layout, Bengaluru – 560095 on lease till 31st March 2033. The Provider has developed the premises into a fully operational business centre equipped with amenities and facilities (fully described in paragraph 9), hereinafter referred to as the “Business Centre”, so as to provide integrated facility services.

Replaced Clause:

The Provider has taken the premises situated at Atlantis, Site Number – 95, 4th B Cross Road, 5th Block, Koramangala Industrial Layout, Bengaluru – 560095 on lease till 31st March 2032. The Provider has developed the premises into a fully operational business centre equipped with amenities and facilities (fully described in paragraph 9), hereinafter referred to as the “Business Centre”, so as to provide integrated facility services.

2. Interpretation

- 2.1 Except as specifically modified by the terms of this Addendum, the Agreement will remain in full force and effect. In the event of any conflict between this Addendum and the Agreement, this Addendum shall prevail.
- 2.2 All defined terms used in this Addendum shall have the same meaning as ascribed to them in the Agreement except that the Agreement shall mean the Agreement as modified by this Addendum.
- 2.3 The recitals and provisions of the Agreement shall form a part of this Addendum and shall have the same force and effect as if expressly set out in the body of this Addendum.
