This **Addendum Number 2 ("Addendum")** to Integrated Facility Services Agreement dated 11<sup>th</sup> July 2019 ('the **Agreement**') is made on 1<sup>st</sup> October 2023.

**BY AND BETWEEN:**

**Go Digit Infoworks Services Private Limited**, a company incorporated and registered under the Companies Act, 2013 having its office at Atlantis, 95, 4th B Cross Road, Koramangala Industrial Layout, 5th Block, Bengaluru – 560095, hereinafter referred to as the "**Service Provider**" (which expression shall, unless it is repugnant to the context or meaning thereof, be deemed to mean and include its successors-in-interest and permitted assigns) **OF THE ONE PART;**

**AND**

**Go Digit General Insurance Limited**, a company incorporated and registered under the Companies Act 2013 and having its registered office at Ananta One ,1 to 6th floor, Opposite Shivaji Nagar bus stand , Babulal Sheikh Path, Narveer Tanaji Wadi, Shivajinagar, Pune, Maharashtra 411005 hereinafter referred to as the "**Client**" (which term, unless it is repugnant to the context or meaning thereof, shall mean and include its successors-in-interest, and permitted assigns) **THE OTHER PART;**

The Service Provider and the Client are hereinafter referred to individually as "Party" and collectively as "Parties".

**WHEREAS:**

- A. In accordance with the terms of the Agreement, the Client had engaged the services (as mentioned in recital A of the Agreement) for occupying the business center situated at unit number 1301 and 1302, 13<sup>th</sup> Floor of "Godrej Colesium", Sion Mumbai - 400022.
- B. Now the Parties, based on mutual consent, agree to amend/ modify certain clauses of the Agreement, as amended from time to time.

**NOW THEREFORE**, in consideration of the terms and conditions set forth herein, the Parties hereby agree as follows:

**1. AMENDMENTS TO THE AGREEMENT**

- 1.1. In consideration of the mutual covenants and promises of the Parties hereto, the receipt and adequacy of which is hereby acknowledged and confirmed by each of the Parties hereto, the Parties hereby agree to amend certain existing provisions in the Agreement in the manner appearing hereinafter in order to reflect the mutual agreement between the Parties hereto.
- 1.2. As per clause 1.2 of the Agreement dated 11th July 2019 the validity of Agreement is from 10th June 2019 to 10th August 2023 which was later extended to 30<sup>th</sup> September 2023. The Parties hereby mutually agree to extend the said Agreement with effect from 1<sup>st</sup> October 2023 till 9<sup>th</sup> August 2028, on the same terms and conditions mentioned in the said Agreement, except wherein the terms are changed through way of any Addendum or exchange of letters etc.

- 1.3. The Parties, based on mutual understanding agree to amend the service fees to be charged by the Service Provider and paid by the Client under the Agreement as amended from time to time, from existing "the total costs incurred by the Service Provider plus an arm's length mark up of 7.39%" to "the total costs incurred by the Service Provider plus an arm's length mark up of 2.95%" with effect from 01<sup>st</sup> October 2023.
- 1.4. The Parties have agreed to increase the Security Deposit to INR 90,00,000/- (Rupees Ninety Lakhs Only).

## 2. MISCELLANEOUS

- 2.1. Each Party represents and warrants to the other Party that this Addendum has been duly authorized, executed and delivered by it and constitutes a valid and legally binding agreement with respect to the subject matter contained herein.
- 2.2. Except as modified by this Addendum, all other terms and conditions of the Agreement shall remain unchanged, shall continue to remain in full force and shall be enforceable between the Parties.
- 2.3. This Addendum and the Agreement constitute the entire agreement and understanding between the Parties.
- 2.4. No variation of this Addendum shall be valid unless it is in writing and signed by or on behalf of each of the Parties.
