## **AMENDMENT NUMBER 1 TO EXPENSE REIMBURSEMENT AGREEMENT**

This is Amendment Number 1 ("**Amendment**") to the Expense Reimbursement Agreement dated 02<sup>nd</sup> February 2023 is hereby executed on 22<sup>nd</sup> February 2024 and shall be effective from 02<sup>nd</sup> January 2024 ("**Effective Date**").

### **BY AND BETWEEN:**

**Go Digit General Insurance Limited**, a public limited company incorporate under the Companies Act 2013 and having its registered address at Ananta One ,1 to 6th floor, Opposite Shivajinagar bus stand , Babulal Sheikh Path, Narveer Tanaji Wadi, Shivajinagar, Pune, Maharashtra 411005 and its corporate office at Atlantis, 95, 4th B Cross Road, Koramangala Industrial Layout, 5th Block, Bengaluru – 560095 ("**GDGIL**"), which expression shall, unless repugnant to the context, mean and include its successors and permitted assigns;

### **AND**

**Go Digit Life Insurance Limited**, a company incorporated and registered under the Companies Act 2013 and having its registered office at Ananta One, Pride Hotel Lane, Narveer Tanaji Wadi, City Survey No.1579, Shivajinagar Pune MH 411005 hereinafter referred to as the "**GDLIL**", which expression shall, unless repugnant to the context, mean and include its successors and permitted assigns;

(GDGIL and GDLIL shall individually be referred to as "**Party**" and collectively be referred to as "**Parties**").

### **WHEREAS:**

- A. GDGIL and GDLIL had entered into Expense Reimbursement Agreement dated 02<sup>nd</sup> February 2023 ("**Principal Agreement**").
- B. GDGIL and GDLIL are desirous of amending certain terms to the Principal Agreement and thus have agreed to set forth the terms which would constitute this Amendment as desired by both the Parties and shall construed to be and read as a part and parcel of the Principal Agreement, which also accordingly stands hereby duly modified.

### **NOW THEREFORE THE PARTIES HERETO HEREBY AGREE AS FOLLOWS:**

1. The below mentioned Work Station expense amount is to be replace under Annexure I, of the Principal Agreement:

#### **Existing Clause:**

Work Station expense: INR 8,225/- (Rupees Eight Thousand Two Hundred Twenty Five Only) per month per seat.

#### **Replaced Clause:**

Work Station expense: INR 11,000/- (Rupees Eleven Thousand Only) per month per seat.

2. The below mentioned Clause 2 of the Principal Agreement shall be replaced and amended as follows:

**Existing Clause:**

The term of this Agreement will begin with effect from date of execution of this Agreement and shall remain valid for a period of eleven (11) months ("Term") with a lock-in period of six (6) months for each Party.

**Replaced Clause:**

The term of this Agreement is renewed with effect from 02<sup>nd</sup> January 2024 and shall remain valid for a period of one (1) year till 01<sup>st</sup> January 2025.

3. The below mentioned Clause 5 of the Principal Agreement shall be replaced and amended as follows:

**Existing Clause:**



GDLIL has paid a sum of Rs. 82,250 /- (Rupees Eighty Two Thousand Two Hundred Fifty Only) equivalent to 10 month's rent to GDGIL towards refundable interest free security deposit. Any escalation in Refundable Security Deposit shall be agreed between the Parties.

**Replaced Clause:**

GDLIL shall pay a sum of Rs. 1,10,000 /- (Rupees One Lakh Ten Thousand Only) equivalent to 10 month's rent to GDGIL towards refundable interest free security deposit. Out of which GDLIL has paid Rs 82,250 (Rupees Eighty Two Thousand Two Hundred Fifty Only) and remaining amount of Rs 27,750 (Twenty Seven Thousand Seven Fifty Rupees Only) to be paid by GDLIL to GDGIL. Any escalation in Refundable Security Deposit shall be agreed between the Parties.

Except the amendment made herein all existing terms and conditions of the Principal Agreement shall continue to remain in effect, save and except those in and related to the Amendment hereby entered between the Parties, and both Parties agree to be bound by the same. In the event of a conflict between the terms of the Principal Agreement and those of this Amendment, the terms of this Amendment shall prevail.

IN WITNESS WHEREOF THE PARTIES HERETO AGREE AND ACCEPT THE TERMS OF THIS AMENDMENT AS AN AMENDMENT TO THE AGREEMENT AND HAVE EXECUTED THIS AMENDMENT ON THE DATE EXECUTED AS BELOW.
