

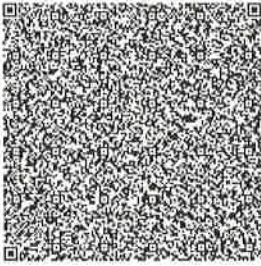

The Assignor and the Assignee are hereinafter referred to individually as "Party" and collectively as "Parties".



WHEREAS:

- 2.4. This Addendum and the Agreement constitute the entire agreement and understanding between the Parties.




