Pursuant to Regulation 30 and Clause 8 of Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 we hereby inform that the Company has received a Demand cum Show Cause Notice ("SCN") dated 22nd September 2025, on Tuesday, 23rd September, 2025 at 01:27 P.M. from the Office of the Commissioner, CGST Audit-I, New Delhi ("the GST Authority") issued under Regulation 74(1) of the Central Goods and Services Tax Act, 2017 and Delhi GST Act, 2017 read with Section 20 of the Integrated Goods and Services Tax Act, 2017, whereby a total demand of ₹ 14,99,37,548/- has been raised by the GST Authority alongwith interest and penalty as may be applicable.
